A NATION IN DISTRESS

- 1. Do you believe that our nation is in distress?
- 2. Do you agree that liberalism is destroying America, and that We the People should repudiate liberalism?
- 3. Do you agree that radical environmentalism is destroying America, and that We the People should repudiate radical environmentalism?
- 4. Do you agree that globalism is destroying America, and that We the People should repudiate globalism?
- 5. Do you agree that the entrenched establishment political class is destroying America, and that We the People should repudiate the entrenched establishment political class?
- 6. Do you agree that our nation faces a clear and present danger from some within our government that are members of what is commonly referred to as "the deep state," and that We the People must be diligent in discovering the actions and intents of such nefarious actors and must vigilantly defend our constitutional Republic from those actors?
- 7. Do you agree that our nation faces a clear and present danger from lawless liberals in cities like Baltimore, Ferguson, Berkeley, Charlottesville, Portland (OR), Minneapolis and Seattle that permit law-

- lessness in order to further their agenda, and from sanctuary cities and sanctuary states that flagrantly violate US immigration law, and from elites that use their resources to foment violence?
- 8. Do you agree that our nation faces a clear and present danger from big technology companies and a complicit federal government that have eroded our right to privacy and threaten free speech and the freedom of association, and that We the People should clamor for the federal government to use useful regulation to severely limit the opportunity for big tech companies to infringe upon our rights to privacy and free speech?

A CALL TO ACTION

- 9. Given that liberals do not have a monopoly on community organization, do you agree that We the People must rally behind a bold, comprehensive, transformational plan of action so that what has been known as the "silent majority" will become the "clamoring majority," as We the People organize ourselves to speak as one, and to move as one?
- 10. Do you agree that We the People should elect more representatives at all levels of government that share the values, principles and policy positions evidenced by the statements and actions of the Freedom Caucus in the U.S. House of Representatives, and that have the backbone to stand firm on principled positions, even when those positions are unpopular and even opposed by a president of the same party?
- 11. Do you agree that rather than form a third party in order to repudiate the entrenched establishment political class as some advocate for, We the People should form a third party within the Republican Party that functions like the House Freedom Caucus within the Republican Party so that we may transform the Republican Party by electing transformational conservatives to all levels of the Republican Party, from precinct officers to county, state and national officers?
- 12. Do you agree that the best way for the Republican Party to select candidates for office is through closed caucus or closed convention?
- 13. Do you agree that the lack of election integrity presents a clear and present danger to our constitutional Republic?
- 14. By constitutional amendment or otherwise, do you agree that We the People must restore election integrity by requiring confirmation by photographic and biometric identification that each voter is a lawfully registered citizen entitled to vote, that early and absentee voting be eliminated, that paper ballots be used on election day with streaming video of the polling locations and other available means used to assure election transparency and integrity?

RESTORE FEDERALISM

- 15. Do you agree that the federal government has usurped the power of the states, and that We the People must restore power to the states, and to the people?
- 16. Do you agree that We the People should compel our states to petition Congress to call for a Convention of States to Propose Amendments?
- 17. Do you agree that, when a Convention of States to Propose Amendments is convened, there should be no limitation on the scope of amendments to be proposed at the convention, as any limitation on the scope of the proposal of amendments at the Convention of States to Propose Amendments would violate Article V of the Constitution?
- 18. Do you agree that if a proposed constitutional amendment that has been presented to the states for ratification has a deadline for ratification, that that deadline for ratification should not be extended?
- 19. Do you agree that, prior to the ratification of a proposed constitutional amendment by three fourths of the states, any state may withdraw its ratification of the proposed amendment, and any state that has previously voted to reject the proposed constitutional amendment may reverse its vote and ratify the proposed amendment that it rejected?
- 20. Since the founders intended that states may propose constitutional amendments as easily as Congress, do you agree that, by constitutional amendment, states should be permitted to directly propose amendments to the Constitution if 2/3 of the state legislatures petition Congress for the proposal of an amendment with identical language, provided that ratification of such amendment by 3/4 of the states be by state conventions?
- 21. Do you agree that the Seventeenth Amendment should be repealed?
- 22. By constitutional amendment or otherwise, do you agree that states should be able to nullify federal actions by the vote of 2/3 of the states?
- 23. By constitutional amendment or otherwise, do you agree that states should have the power to remove federal officers by a 2/3 vote of the states?
- 24. By constitutional amendment or otherwise, do you agree that states have a natural right to secede from the union, and that that natural right to secede should be affirmed, and the manner by which states may peacefully secede should be prescribed?

RESTORE NATIONAL SOVEREIGNTY

25. Do you agree that national security should be restored as the first priority of the federal government, and that the United States should again pursue a policy of "speaking softly and carrying a big stick" by rebuilding our military and our capacity to wage war to a point that it is unmatched by any combination of our adversaries?

- 26. Since radical Islam has declared war on all of Western civilization, do you agree that the United States should declare war on radical Islamic terrorism and give the president, as commander-in-chief, the broad authority to conduct asymmetric military operations to fight terrorism when he deems it necessary?
- 27. Article IV, Section 4 of the Constitution states that the federal government shall protect the states from invasion. Do you agree that the federal government has failed in its duty to protect the states from invasion of illegal persons and drugs along our southern border?
- 28. Do you agree that the United States should immediately militarize the border with Mexico by deploying active military, National Guard and citizen militia groups as needed in order to immediately secure our southern border from infiltration of illegal persons, drugs or other threats of invasion while engaging private firms to assist in the design and construction of adequate walls and technology barriers that will continue to be guarded by our military?
- 29. Given that the drug cartels in Mexico have infiltrated the Mexican government, have associations with ISIS and other terrorist groups and have caused great harm to our nation through the importation of drugs, do you agree that the United States should take unilateral action against the drug cartels by any means necessary?
- 30. Do you agree that no amnesty should be granted to illegal immigrants, and that immigration laws should be enforced in order to remove incentives for people to be here illegally and to incentivize those that are here illegally to self-deport?
- 31. Do you agree that anyone that has been granted amnesty should be denied citizenship, and hence the right to vote?
- 32. Do you agree that any naturalized citizen that does not assimilate, or that is a proponent of sharia law, which is incompatible with our Constitution, should lose their United States citizenship and be subject to deportation?
- 33. In order to secure relief from the deleterious effects of the 1965 Immigration Act on the American economy and the American worker, do you agree that the United States should impose a temporary moratorium on all immigration?
- 34. Do you agree that the United States should withdraw from the United Nations, expel the United Nations from American soil, and encourage other freedom loving nations to also withdraw from the United Nations?
- 35. Do you agree that the United States has a special obligation to promote liberty and resist tyranny throughout the world?
- 36. Do you agree that nations can be classified on a freedom scale as friends and allies or adversaries and enemies, and that the United States should show favor to friends and allies and to adversaries that seek to move up the freedom scale towards more liberty, and that the United States should show disfavor to those adversaries and en-

- emies that are moving down the freedom scale toward greater tyranny?
- 37. Do you agree that the United States should set the example of moving up the freedom scale by empowering United States citizens with greater personal and economic liberty, and that we should therefore show some humility in encouraging and coaxing other nations to move up the freedom scale?
- 38. Do you agree that free trade and fair trade are impossible and imprudent, and that the United States should instead pursue secure, strategic trade?
- 39. Instead of providing so much foreign aid to and selling high-tech armaments to nations that may possibly turn against the United States in the future, do you favor the establishment of American Enterprise Zones with willing host nations that are of strategic interest to the United States whereby ninety-nine year leases are established in territories of significant size within the host country that would permit the United States military and private security forces to establish security and allow American enterprises to develop infrastructure, mining, agriculture, manufacturing and other enterprises to the mutual benefit of the United States and the host nation?
- 40. As the only democratic nation in the Middle East, and our strongest ally in the region, do you agree that the United States should be unwavering in our support of Israel, and the right that Israel has to national sovereignty, security and self-determination?
- 41. Do you agree that President Vladimir Putin of Russia has effectively established himself as the new czar of Russia, and that despite the popularity of Putin in Russia, the United States should decisively check the expansionist ambitions of Russia in countries like Syria, Ukraine and Crimea, and staunchly defend against Russian expansion in countries like the Baltic states or any nation in Western Europe or the Western Hemisphere?
- 42. Do you agree that China has been waging economic warfare against the United States for decades, and that the United States must retaliate in a decisive way by pursuing secure, strategic trade and removing the constraints that the federal government has placed on us as Americans that restrict the output that We the People could produce if economic liberty was restored to American citizens?

RESTORE INDIVIDUAL LIBERTY

- 43. By constitutional amendment or otherwise, do you agree that We the People should protect all life from conception until natural death, rendering abortion, assisted suicide and euthanasia illegal?
- 44. Do you believe that marriage was defined by God as between a man and a woman, was ordained by God before any government was established, is a natural right that should require no license or govern-

- ment approval, and should only be limited by a lawful restriction on closeness of relation?
- 45. Do you agree that we should propose and ratify a constitutional amendment that defines marriage as between a man and woman?
- 46. By constitutional amendment or otherwise, do you agree that the right of individuals and business entities to refrain from engaging in business in a manner that violates their beliefs should be protected as free speech, religious liberty and freedom of association?
- 47. Do you agree that the second amendment does not grant citizens the right to keep and bear arms, but rather acknowledges the natural right that individuals have to keep and bear arms?
- 48. By constitutional amendment or otherwise, do you agree with protecting the individual right of citizens to bear arms openly or concealed anywhere, with the exception of venues defined by Congress that have been properly secured and have adequate armed law enforcement personnel within the venue, effectively eliminating gunfree zones?
- 49. Do you agree with constitutional carry and national reciprocity?
- 50. By constitutional amendment or otherwise, do you agree that the right to keep and bear arms should not be infringed by any tax, license, quantity limitation or registration?
- 51. By constitutional amendment or otherwise, do you agree that all taxes on personal, financial and real property should be eliminated, which would abolish property taxes and estate taxes?
- 52. By constitutional amendment or otherwise, do you agree that there should be no federal or state wage or price controls, which would eliminate the minimum wage and permit the free market to set wages and prices?
- 53. By constitutional amendment or otherwise, do you agree that the right to work without compulsory union membership or dues should be assured to all citizens of all states?

RESTORE LIMITED GOVERNMENT

- 54. By constitutional amendment or otherwise, do you agree that all income should be taxed at the same flat rate, not to exceed 15%, and that all exemptions, deductions and preferences should be eliminated?
- 55. By constitutional amendment or otherwise, do you agree that, in combination with a flat federal income tax not to exceed 15%, an upper limit of 5% should be established for any future national sales tax?
- 56. Do you agree that, in the context of a flat tax on all income not to exceed 15%, dividends paid by corporations from income that has already been taxed should not be taxable to shareholders?

- 57. Do you agree that we should propose and ratify a balanced budget amendment to the Constitution?
- 58. Do you agree that we should propose and ratify a constitutional amendment giving the president a line-item veto over expenditures proposed by Congress?
- 59. Do you agree that we should propose and ratify a constitutional amendment that limits the time that congressmen can serve to no more than eight years, and the time that senators can serve to no more than twelve years?
- 60. Do you agree that we should propose and ratify a constitutional amendment that limits the time that a president may serve to one term of six years, plus no more than two years of the term of another person that previously served as president?
- 61. By constitutional amendment or otherwise, do you agree that federal employees should be employees-at-will, and that they should be prohibited from forming unions for collective-bargaining purposes?
- 62. By constitutional amendment or otherwise, do you agree that we should abolish the IRS?
- 63. Do you agree that we should dramatically reduce federal spending by getting the federal government out of activities for which there is no constitutional authority, that are in fact infringements upon states' rights?
- 64. Do you agree that the federal government should use zero-based budgeting to reauthorize every dollar of federal spending every two years in order to reduce wasteful spending?
- 65. Do you agree that the primary function of the federal government is national defense and national security, and that non-defense spending should be reduced by at least 75%?
- 66. Do you agree that the federal government does not follow the preamble to the Constitution to promote the general welfare, but has rather unconstitutionally engaged in promoting the specific welfare of a multitude of special interests and tens of millions of individuals, leading to massive redistribution of wealth and an unhealthy dependency upon government?
- 67. Do you agree that the federal government has things backwards when they classify defense spending as discretionary spending, and non-defense spending as nondiscretionary?
- 68. Do you agree that We the People should dismantle Social Security in a manner whereby the cost and pain of doing so will be shared by all Americans, including those that have managed to opt out of the Social Security system?
- 69. Do you agree that the federal government should transfer Medicare and Medicaid to the states, and that states would be prudent to dismantle Medicare and Medicaid in order to pursue free-market healthcare?

- 70. Do you agree that the federal government should dismantle welfare entitlement programs such as unemployment and food stamps?
- 71. Do you agree that the federal government should stop subsidizing cities at the expense of rural America by encouraging the development of decentralized and distributed technologies that will help all Americans instead of spending federal dollars on infrastructure projects that favor cities?

UNLEASH FREE-MARKET CAPITALISM

- 72. Do you agree that there is an abundance of resources on earth for free people living in free markets to produce all of the goods and services needed to enjoy life, liberty and the pursuit of happiness, and that it is tyranny, oppression and the restriction of individual liberty that create conditions leading to poverty and economic slavery?
- 73. Do you agree that steady, gradual deflation is the natural result of the operation of free markets, and that inflation is artificially imposed by the suppression of output and the control of capital?
- 74. By constitutional amendment or otherwise, do you agree that the quantity of currency that is authorized by Congress to be issued be limited based upon the quantity of gold held in reserve, and that no reduction in the quantity of gold held in reserve be permitted?
- 75. By constitutional amendment or otherwise, do you agree that the Federal Reserve and fractional banking should be eliminated?
- 76. By constitutional amendment or otherwise, do you agree that the right of American citizens to transact business with cash, gold, crypto-currencies, barter or other money substitutes should be protected?
- 77. Do you agree that individuals should be permitted to make direct investments in small business through block chain enabled equities in a decentralized and distributed fashion free of SEC regulation?
- 78. Given that global debt is spiraling out of control, with global debt increasing from approximately \$146 trillion in 2007 to approximately \$233 trillion in 2014, do you agree that it seems inevitable that the global financial system will collapse?
- 79. Given that global debt is escalating dramatically more quickly than global real wealth could possibly grow, do you agree that the massive amount of debt is effectively enslaving the vast majority of people on earth, and that it is quite likely the intended result of global elites seeking to consolidate political and economic power?
- 80. Do you agree that financial market discussions of negative interest rates, discussions of "bail-ins," where depositor funds are used to bail-out failed banks, and discussions of special drawing rights established by central bankers are all indicators that global elites fully expect an imminent reset of the global financial system?

- 81. Do you agree that We the People have the liberty to preempt the reset of the global financial system by the global elites by initiating our own reset of the global financial system that would bring the hope of economic liberty and prosperity to all instead of the tyranny and totalitarianism that would be imposed upon most people if the globalists have their way?
- 82. Do you agree that the United States should call for a global Year of Jubilee whereby all nations collectively agree that most nations are effectively bankrupt, and that we should all recognize that reality by resetting the global financial system by eradicating all debt and abolishing all central banks?
- 83. Even if other countries do not follow the lead of the United States, do you agree that the United States should declare a Year of Jubilee in the United States, whereby all debt is canceled or converted to equity, the Fed is abolished and debt is outlawed?
- 84. Given that the American worker and small business owners are the most important elements of any plan to revive the American economy in the context of declaring a Year of Jubilee, do you agree that in order to bring the greatest economic liberty to the largest and most important segment of the United States economy, all credit card debt, student loan debt, other unsecured consumer debt, and all mortgages and liens against all owner-occupied single-family or duplex dwelling units should be completely forgiven?
- 85. In the context of a Year of Jubilee, do you agree that mortgages on multifamily real estate units should be converted to an equitable sharing of equity by granting debtholders equity in each property equal to 50% of the loan-to-value ratio prior to the implementation of the Year of Jubilee, and that for the first year, landlords be prohibited from evicting any tenants that are paying rent at a percentage of household income established by Congress?
- 86. Given that parties in possession are the most trustworthy and competent to entrust with the challenge of keeping the wheels of the economy turning in the context of a Year of Jubilee, do you agree that, unless businesses and non-residential property owners and their creditors can voluntarily agree to converting debt to equity, debtholders should receive equity in each property or business equal to half of the percentage of debt in the original capital structure prior to the implementation of the Year of Jubilee?
- 87. Do you agree that, in the context of a Year of Jubilee, it would be important to eliminate wage and price rigidity and to also eliminate all future claims such as pensions, Medicaid, Medicare and Social Security so that the free market can quickly establish new wages and prices?
- 88. Since Congress was given the constitutional authority to establish federal courts that are inferior to the Supreme Court and to establish the jurisdiction of those courts, do you agree that Congress should

- use its power to reshape the federal judiciary to eliminate judicial tyranny in matters of citizenship, immigration, elections, marriage, and abortion by eliminating the jurisdiction of lower federal courts over those matters?
- 89. Do you agree that the United States should pursue free-market energy by permitting the free market to produce cheap, abundant, domestic energy by pursuing an "all of the above" energy policy that does not subsidize new technologies and does not penalize the fossil fuels that were used to build the greatest economic engine in history?
- 90. Given the much-publicized threat of an electromagnetic pulse attack upon our vulnerable centralized power grid, do you agree that federal government policy should encourage the decentralized and distributed generation of electric power, as well as the hardening of the existing power grid?
- 91. Do you agree that the federal government should stop defining carbon dioxide as a pollutant?
- 92. Do you agree that the federal government should stop imposing fuel efficiency standards for vehicles?
- 93. Do you agree that health insurance coverage does not mean that people will receive adequate healthcare and that Obamacare was unconstitutionally foisted upon Americans and should be repealed, permitting the free market to operate without Obamacare?
- 94. Do you agree that, in order to pursue free-market healthcare, government at all levels must be eliminated as third-party payers in the healthcare market?
- 95. Do you agree that, in order to pursue free-market healthcare, health insurance companies should be eliminated as third-party payers through federal legislation that makes health insurance policies illegal?
- 96. Do you agree that by eliminating government and insurance companies as third-party payers, healthcare costs will fall precipitously, that Americans will more easily afford routine healthcare, and will have a multitude of options for sharing catastrophic healthcare costs?
- 97. Do you agree that government at all levels should extricate themselves from education and permit We the People to pursue twenty-first century free-market education where parents are permitted to fulfill their responsibility to educate and indoctrinate their children in accordance with their values and beliefs?
- 98. Since learning the value of hard work is important to a well-rounded education, do you agree that children should be permitted to work, regardless of age, so long as the safety of each child is assured?
- 99. Do you agree that we should reverse the degradation of the right of American citizens to acquire, enjoy and dispose of property by eliminating taxes on property, limiting zoning and code enforcement laws to life-safety issues, limiting the extortion of property development, reining in the tyranny of homeowner associations, compensat-

ing property owners in imminent domain takings at twice the market value of the property taken, prohibiting civil asset forfeiture without due process, repealing tyrannical environmental laws, restoring the right of citizens to grow food and raise livestock and removing government impediments to the use of property?
